Send three (3) close-ups, one of each different item you will be exhibiting. Send one image of your normal booth setup. Print your name and address on each CD/photograph. Include a self-addressed, stamped envelope for return of your CD/Photographs. (Fine Arts & Fine Crafts only.)
