In this instance, no refunds will be issued. Facsimiles of your work should be submitted in the form of: 35mm slides, jpeg files on CD, or photographs (no smaller than 5 x 7). Send three close-ups, one of each different item you will be exhibiting. Send one image of your normal booth setup. Print your name and address on each slide/CD/photograph. Include a self-addressed stamped envelope for return of slides/CDs/photographs. Slides/CDs/photographs of chosen work will be returned during the Festival.

Weights for tents are strongly recommended (in the event of high winds). Exhibitor further understands that MGAA reserves the right to remove any work or display from exhibition. Exhibitor acknowledges that he/she assumes the risk that the Festival may be cancelled due to inclement weather or any other reason at the sole discretion of the Middle Georgia Art Association. In the event of cancellation all fees are non-refundable to the exhibitor.
